This is an agreement between the Photographer, the Videographer, and the couple getting married. The Photographer and Videographer will perform photography services on the date of _____. The Photographer and the Videographer will be at the Church approximately ½ hour before the ceremony, unless otherwise specified. The complete Wedding Package covered by this contract includes photos and video of the ceremony, formal shots at the church, and any other photos the couple request at the Church. The complete reception, including any stop that couple wish to make on the way to the reception, the wedding cake, the garter toss, the bouquet toss, first dance, father/daughter...mother/son dance, and any other photos that the couple request, at the FLAT RATE of **\$3495 + **plus lab fees for printing of the proofs.** (Color correction and art work are included.) Cal will provide the couple with a copy of all the proofs (4" x 6") at his wholesale cost, if so desired, and a copy of all the digital files (at no extra charge). The Videographer will provide a DVD of the Wedding, including all artwork and transition, music, and whatever editing is necessary, delivered in a wedding style DVD album case. Also included is the custom montage album (a custom-made wedding album designed by the couple and the photographer.) This Agreement releases all copyrights that the photographer holds on the photographs; however, Creative Images by Cal reserves the right to make copies for promotional purposes. This agreement guarantees that the wedding date specified above will be held open for the signing parties. A deposit of \$250 is required and will be credited toward the total of the service. **CANCELLATION BY THE COUPLE WILL RESULT IN THE FORFEITURE OF THE DEPOSIT.** All reasonable attempts will be made to accommodate changes to a different date, if possible. The Photographer will do everything in his power to ensure the highest quality of photographs possible, but assumes no liability for mistakes made by the Lab, or for malfunction of equipment. In the unlikely event the photographs are undeliverable, the entire amount of the service, including the deposit, will be refunded. The deposit of **\$250** is due upon **signing of this contract** and the balance of **\$3245**, for the service, is due the night **of the wedding** date indicated above. **Lab fees are due at the time the proofs are delivered**, usually within 14 business days. *State and local taxes due apply.*
